## High Powered Floor Restoration wants to ensure that you are completely satisfied with our products and services.

Follow these simple conditions to keep your warranty current, and to ensure you're eligible for our replacement or money back guarantees.

### Re-application and Warranty Terms

High Powered Floor Restoration will re-apply sealant at its own expense if:

- 1.0 At any time during the warranty period, the sealant has worn away from normal domestic use only.
- 2.0 The sealant has not been applied in accordance with the manufacturer's directions.
- 3.0 The sealant does not perform to the manufacturer's specifications.
  - 3.1 In the event the sealant does not perform in accordance with manufacturer's specifications upon a second application, the warranty holder will be given a full refund of the sealant price only.

### Warranty Validity

- 4.0 For the warranty to be valid, you must:
  - 4.1 Have the sealant inspected every twelve months by a certified High Powered Floor Restoration inspector.
  - 4.2 A fee of \$110.00 is payable upon inspection.
  - 4.3 High Powered Floor Restoration will re-apply the sealant at its own expense only if a High Powered Floor Restoration Inspector deems that any areas need to be re-sealed

due to normal domestic use. If a High Powered Restoration Approved Inspector deems that any area needs to be resealed for any other reason, a re-application fee may apply.

- 5.0 The warranty is void if:
  - 5.1 A harsh cleaner is used on the sealant. You may purchase an appropriate cleaner from High Powered Floor Restoration.
  - 5.2 Any high heat cleaning applications are used.
  - 5.3 Any unapproved sealants, waxes, finishes or cleaners are applied or reapplied to the sealant surface.
  - 5.4 Any damage is caused by acid based stains.
  - 5.5 The warranty holder fails to have the sealed floor inspected as required in clause 4.1.
- 6.0 The warranty is valid for ten years from the date of purchase/application.
- 7.0 The warranty is non-transferrable.
  - 7.1 If the warranty holder sells the property in which the hard surface sealant has been applied, the warranty will cease from the date of settlement.
  - 7.2 If the warranty holder leases to tenants the property in which the hard surface sealant has been applied, the warranty will cease from the date of the lease.
